

CITY OF LOOKOUT MOUNTAIN, GEORGIA

ORDINANCE NO. 255

AN ORDINANCE to amend Ordinance Nos. 88 and 237 of the City of Lookout Mountain, Georgia, to increase the annual license fee for motor vehicles operated within the City, and for other purposes.

BE IT ORDAINED by the Council of the City of Lookout Mountain, Georgia, and it is hereby ordained:

SECTION 1. Section 4 of Ordinance No. 88, as heretofore amended by Ordinance No. 237, is hereby amended by the deletion of subparagraph (a) of said section and the substitution of the following subparagraph in lieu thereof:

(a) There is hereby levied an annual license fee of Five Dollars (\$5.00) for each Motor Vehicle operated within the City by a Resident; provided, however, that such fee shall be in the amount of Ten Dollars (\$10.00) if paid on or after June 1 of the year for which the fee is due.

Sections 4(b) and (c) of Ordinance No. 88 shall remain in full force and effect, unaffected by this amendment.

SECTION 2. The second sentence of Section 5(b) of Ordinance No. 88, as heretofore amended by Ordinance No. 237, is hereby amended by deleting from said sentence the reference to the "Three Dollar (\$3.00) annual license fee" and substituting therefor the "Five Dollar (\$5.00) annual license fee" now provided by Section 4(a) of Ordinance No. 88.

SECTION 3. In all other respects, the City of Lookout Mountain's Ordinance No. 88, as heretofore amended by Ordinance No. 237, shall remain in full force and effect, unaffected by the foregoing amendments.

SECTION 4. Savings Clause. If any of the sections, subsections, sentences, clauses or phrases of this Ordinance are for any reason held to be unconstitutional or invalid, the validity of the remaining portions of this Ordinance shall not be thereby affected since it is the express intent of the Council of the City to pass each section, phrase, paragraph and word separately.

SECTION 5. Repealer. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION 6. Part of Code of Ordinances. It is the intention of the Council of the City that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City, and the Sections of this Ordinance may be renumbered to accomplish such intention.

SECTION 7. Effective Date. This Ordinance shall be effective ten (10) days after its adoption and approval by at least three (3) members of the Council of the City of Lookout Mountain, Georgia, after two (2) readings at least one (1) week apart.


