

CITY OF LOOKOUT MOUNTAIN, GEORGIA

ORDINANCE NO. 8

AN ORDINANCE

To add to the Code of Ordinances of the City of Lookout Mountain, Georgia, rules and regulations for the construction, alteration, removal, demolition, equipment, use and occupancy, location and maintenance of buildings and structures, including the issuance of permits and the levy of penalties;

BE IT ORDAINED by the City Council of the City of Lookout Mountain, Georgia, and it is hereby ordained:

Section 1. The following Chapter is herewith added to the Code of Ordinances of the City of Lookout Mountain, Georgia:

CHAPTER 6

Sec. 6-1. There is hereby adopted by the City of Lookout Mountain, Georgia, that certain building Code known as Southern Standard Building Code, published by Southern Building Code Congress, Birmingham, Alabama, being particularly the 1965 edition thereof and the 1968 revision to the 1965 edition, and the whole thereof, save and except such portions as are hereinafter deleted, modified or amended, of which not less than one copy has been placed on file in the office of the Clerk of the City of Lookout Mountain, Georgia, and the same is hereby adopted and incorporated as fully as if set out at length herein; the provisions thereof shall be controlling in the construction of all buildings and structures therein contained within the corporate limits of the City of Lookout Mountain, Georgia.

Sec. 6-2. Part of Code of Ordinances.

It is the intention of the governing body and it is hereby ordained that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of the City

of Lookout Mountain, Georgia, and the sections of this ordinance may be renumbered to accomplish such intention.

Sec. 6-3. Repealer.

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Sec. 6-4. Effective Date.

BE IT FURTHER ORDAINED by the City Council of the City of Lookout Mountain, Georgia, and it is hereby ordained that due to the immediate need for high quality standards in the construction and alteration of buildings and other structures in the City of Lookout Mountain, Georgia, for the protection of the residents of the City, an emergency exists and the public safety and welfare require that this ordinance be effective upon its adoption and approval by at least four (4) members of the Council of this City on two readings less than one (1) week apart and that this ordinance shall therefore be effective immediately upon such approval after such two readings and its adoption following the second of such readings.
