

CITY OF LOOKOUT MOUNTAIN, GEORGIA

ORDINANCE NO. 7

AN ORDINANCE

To amend Chapter 2, Division 2, of the Code of Ordinances of the City of Lookout Mountain, Georgia, by requiring a further provision in the agreement provided for under Section 2-58.

BE IT ORDAINED by the City Council of the City of Lookout Mountain, Georgia, and it is hereby ordained:

Section 1.

That Section 2-58 of the Code of Ordinances of the City of Lookout Mountain, Georgia, is hereby amended to read as follows:

"(c) Such agreement shall also contain a provision requiring the registrant to procure and cause to be deposited forthwith in the office of the Chief of the Fire Department a certificate of fire insurance in a company authorized to do business in the State of Georgia which shall contain a clause conditioned to pay the City the sum of Two Hundred Fifty Dollars (\$250.00) in case the Fire Department is called because of a fire in, on, or exposure thereto of the insured property. The certificate of insurance shall give the name and address of the insured, shall state the coverage of the policy and the location of the property and shall be signed by an agent of the insurance company furnishing such insurance."

Section 2. Effective Date:

BE IT FURTHER ORDAINED by the City Council of the City of Lookout Mountain, Georgia, and it is hereby ordained that due to the immediately impending discontinuance of fire protec-

tion to the people of Dade County formerly served by Fairyland Fire District and the need of such people for protection without interruption and for the City Government to be able to furnish such protection by entering into agreements between such people and the City, an emergency exists and the public safety and welfare require that this ordinance be effective upon its adoption and approval by at least four (4) members of the Council of this City on two readings less than one (1) week apart, and that this ordinance shall therefore be effective immediately upon such approval after such two readings and its adoption following the second of such readings.
