ORDINANCE NO. 16

AN ORDINANCE

Authorizing the acceptance of pleas of guilty in certain cases and imposing a fine in such cases.

BE IT ORDAINED by the City Council of the City of Lookout Mountain, Georgia, and it is hereby ordained:

Section 1. The Chief of Police, or his authorized delegate is herewith authorized and directed to accept pleas of guilty in parking violation cases and in stop sign violation cases without the necessity of issuing a warrant requiring any such person desiring to plead guilty to appear before the City Court.

Section 2. The plea of guilty shall not be accepted by the Police Department in any case in which one of the violations appears in conjunction with other violations, either of the laws of this City or of the State of Georgia, nor shall it be accepted if the party desiring to plead guilty has previously been convicted of or pleaded guilty to a traffic violation within the preceding six (6) months' period.

Section 3. The Chief of Police or his authorized delegate is authorized and directed to accept at the City Hall only, and there is hereby imposed, a fine of Ten Dollars (\$10.00) inclusive of all court costs for each stop sign violation and Two Dollars (\$2.00) inclusive of all court costs for each parking violation.

Section 4. If any section, subsection, sentence or clause in this ordinance be judged invalid, such adjudication shall not affect the validity of the ordinance or code as a whole or of any section, subsection, sentence or clause hereof or thereof not adjudged invalid.

Section 5. Part of Code of Ordinances.

It is the intention of the governing body and is hereby ordained that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of the City of Lookout Mountain, Georgia and the sections of this ordinance may be renumbered to accomplish such intention.

Section 6. Effective Date.

This ordinance shall be effective ten (10) days after its adoption and approval by at least three (3) members of the Council of this City after two readings at least one week apart.
