CITY OF LOOKOUT MOUNTAIN, GEORGIA ORDINANCE NO. _//9

AN ORDINANCE

To amend Ordinance No. 94 as amended by Ordinance Nos. 98, 104 and 118; to regulate the storage of refuse by multiple dwellings and commercial establishments; and for other purposes:

BE IT ORDAINED, by the City Council of the City of Lookout Mountain, Georgia, and it is hereby ordained:

SECTION 1. Ordinance No. 94, as amended by Ordinance No. 98, is hereby amended by striking in its entirety subparagraph (B) of Section 4.4 and substituting in lieu thereof a new Section 4.4(B) to read as follows:

(B) The City shall provide at least one standard container for each multiple dwelling in the City and may supply such additional number of standard containers as, in the sole judgment and discretion of the City, are required for the storage and collection of refuse generated by the multiple dwelling.

The remainder of the aforesaid Section 4.4 shall remain unchanged and unaffected by this amendment.

SECTION 2. Ordinance No. 94, as amended by Ordinance No. 98, is further amended by the addition of a new subparagraph to Section 5 of Ordinance No. 94, which subparagraph shall be designated as Section 5.1 and shall read as follows:

5.1 Commercial Establishments and Multiple

Dwellings. Commercial establishments
and multiple dwellings in the City shall
be required to have such number of
standard containers as, in the sole
judgment and discretion of the City, is
necessary for the storage and collection
of the refuse generated by such commercial establishment or multiple dwelling.
Charges for refuse removal services
rendered to commercial establishments

and multiple dwellings shall be as established by the City in accordance with Section 7 hereof.

SECTION 3. PART OF CODE OF ORDINANCES. It is the intention of the governing body and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Lookout Mountain, Georgia, and the sections of this Ordinance may be renumbered to accomplish that intention.

SECTION 4. SEVERABILITY. If any section, subsection, sentence, or clause of this Ordinance be adjudged invalid, such adjudication shall not affect the validity of the ordinance as a whole or of any section, subsection, sentence or clause hereof not adjudged invalid.

SECTION 5. REPEALER. All other ordinances or parts thereof heretofore enacted by the City, in conflict herewith are hereby repealed.

SECTION 6. EFFECTIVE DATE. This Ordinance shall be effective ten (10) days after its adoption by at least three (3) members of the Council of the City after two (2) readings at least one (1) week apart.
