ORDINANCE NO. 217

AN ORDINANCE to amend the City of Lookout Mountain, Georgia's Ordinance

No. 187 by modifying the schedule of sewer service charges set forth in Section 2-6 thereof, and

for other purposes.

BE IT ORDAINED by the City Council of the City of Lookout Mountain, Georgia, and

IT IS HEREBY ORDAINED:

Section 1. The City of Lookout Mountain, Georgia's Ordinance No. 187 is hereby

amended by the deletion of Section 2-6 thereof in its entirety and the substitution of the

following therefore:

Sec. 2-6. Schedule.

Enumeration of Charges; Quantity of Water Used. Sewer service charges shall be based upon the quantity of water used as shown by water meter readings and shall be the dollar amount derived by applying the total charge in dollars per one hundred (100) cubic feet for the quantities of water shown in the following table:

Sewer Usage Charges

100	Rates per
<u>Cubic Feet</u>	100 Cubic Feet
First 4	\$0.56
All over 4	\$4.37

In all other respects, Ordinance No. 187 shall remain in full force and effect, unaffected by this amendment.

<u>Section 2</u>. <u>Severability</u>. If any of the sections, subsections, sentences, clauses or phrases of this Ordinance are for any reason held to be unconstitutional or invalid, the validity of the remaining portions of this Ordinance shall not be affected, since it is the express intent of the Council of the City to pass each section, phrase, paragraph and word separately.

Section 3. Part of Code of Ordinances. It is the intention of the Council and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Lookout Mountain, Georgia, and the sections of this Ordinance may be renumbered to accomplish such intention.

Section 4. <u>Repealer</u>. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. Effective Date: This Ordinance shall be effective ten (10) days after its adoption by at least three (3) members of the Council of the City after two (2) readings at least one (1) week apart.
