## CITY OF LOOKOUT MOUNTAIN, GEORGIA

## **ORDINANCE NO. 300**

AN ORDINANCE to amend the City of Lookout Mountain, Georgia's Ordinance No. 187, as heretofore amended, to provide that the sewer service charges authorized by Section 2-6(a) of said ordinance will be at rates from time to time established by the Council of the City, and for other purposes.

BE IT ORDAINED by the City Council of the City of Lookout Mountain, Georgia, and IT IS HEREBY ORDAINED:

- Section 1. The City of Lookout Mountain, Georgia's Ordinance No. 187, as heretofore amended, is hereby amended by the deletion of Section 2-6(a) thereof in its entirety and the substitution of the following therefor:
  - (a) Sewer Service Charges; Quantity of Water Used. Sewer service charges shall be based upon the quantity of water used as shown by water meter readings and shall be the dollar amount derived by applying monetary rates per gallon, cubic feet or other measure to the quantities of water used. The rates per gallon, cubic feet, or other measure of water used shall be established from time to time by the Council of the City and may be different for different quantities of water used.

In all other respects, Ordinance No. 187, as heretofore amended, shall remain in full force and effect, unaffected by this amendment. In particular, Section 2-6(b) of said ordinance, as added by Ordinance No. 267 and providing for additional monthly service charges, shall remain in full force and effect.

Section 2. Severability. If any of the sections, subsections, sentences, clauses or phrases of this Ordinance are for any reason held to be unconstitutional or invalid, the validity of the remaining portions of this Ordinance shall not be affected, since it is the express intent of the Council of the City to pass each section, phrase, paragraph and word separately.

Section 3. Part of Code of Ordinances. It is the intention of the Council and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Lookout Mountain, Georgia, and the sections of this Ordinance may be renumbered to accomplish such intention.

Section 4. Repealer. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. Effective Date. This Ordinance shall be effective ten (10) days after its adoption by at least three (3) members of the Council of the City after two (2) readings at least one (1) week apart.
