

CITY OF LOOKOUT MOUNTAIN, GEORGIA

ORDINANCE NO. 324

AN ORDINANCE to amend Section 10-2 of the Code of the City of Lookout Mountain, Georgia (the "City Code"), to provide for the appointment of the election officials of the City of Lookout Mountain, and for other purposes.

BE IT ORDAINED by the City Council of the City of Lookout Mountain, Georgia, and
IT IS HEREBY ORDAINED:

Section 1. Section 10-2(a) of the City Code is deleted in its entirety and replaced with the following:

(a) At a regular or properly noticed special meeting of the council, the council shall appoint, by resolution, a municipal superintendent who shall perform the duties specified by the election code. The municipal superintendent shall be a judicious, intelligent and upright citizen of the United States and shall be impartial and unbiased. The municipal superintendent shall appoint poll officers, in accordance with the election code and in consultation with the mayor, to conduct elections and primaries in the City. Such poll officers shall include a chief manager, two assistant managers, and as many clerks as are necessary to aid and assist in the conduct of the elections and primaries. Such poll officers shall have the qualifications specified by the election code and, before entering upon their duties, shall take an oath of office as required by the election code which shall be substantially as follows:

"I do solemnly swear that I will faithfully and impartially discharge, to the best of my ability, the duties imposed upon me by law as _____ of the City of Lookout Mountain, Georgia."

Section 10-2(b) of the City Code shall remain in full force and effect, unaffected by this Ordinance.


Section 2. Savings Clause. If any of the sections, subsections, sentences, clauses or phrases of this Ordinance are for any reason held to be unconstitutional or invalid, the validity of the remaining portions of this Ordinance shall not be thereby affected since it is the express intent of the Council of the City to pass each section, phrase, paragraph and word separately.

Section 3. Repealer. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.


Section 4. Part of Code of Ordinances. It is the intention of the Council of the City that the provisions of this Ordinance shall become and be made a part of the City Code, and the sections of this Ordinance may be renumbered to accomplish such intention.

Section 5. Effective Date. This Ordinance shall be effective ten (10) days after its adoption and approval by at least three (3) members of the Council for the City of Lookout Mountain, Georgia, after two (2) readings at least one (1) week apart.
